

## **Summary Annual Report**

### **For Genesis Energy, LLC Profit Sharing & Retirement Savings Plan**

This is a summary of the annual report for Genesis Energy, LLC Profit Sharing & Retirement Savings Plan, Employer Identification Number 80-0321477, Plan No. 014 for the period January 01, 2017 through December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses were \$12,301,755. These expenses included \$93,371 in administrative expenses and \$12,186,345 in benefits paid to participants and beneficiaries and \$22,039 in other expenses. A total of 1374 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$113,331,688, as of December 31, 2017 compared to \$92,930,847 as of January 01, 2017. During the plan year, the plan experienced an increase in its net assets of \$20,400,841. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$32,702,596, including employer contributions of \$9,170,588, employee contributions of \$7,698,334, other contributions of \$817,267, realized gains of \$1,473 from the sale of assets, and earnings from investments of \$15,014,934.
